### **JANUARY SERMONS**

Sunday, January 1, 10 a.m., "A Service of Remembrance," Lay Leaders: Mac & Susan Goekler, Peter Schott, Micah Jung, and Marta Dominguez: We take time at the beginning of a new year to celebrate the lives of people who affected our lives directly or indirectly and to remember those who died this past year. During this service we acknowledge their contributions, which help make us who we are today. We will celebrate through words, images, and music. This is a celebration of life. Those that are remembered are with us. Please note: Incense will be burned in the front of the sanctuary during the meditation time. If this will be a problem for you, please feel free to sit in the back or go to the gathering area during the meditation.

**Sunday, January 8, 10 a.m., "Why Bother?" Rev. Heather Rion Starr:** Drawing upon Elizabeth Andrew's lovely book, *Writing the Sacred Journey: The Art and Practice of Spiritual Memoir*, we'll consider "why bother?" Why bother remembering, sharing, telling, and perhaps even getting our own life stories down on paper? How is telling the story of something that happened, perhaps decades ago, a spiritual practice? (And, really, is it?)

*Sunday, January 15, 10 a.m., "I Come Not to Praise King," Rev. Heather Rion Starr:* Challenged by the prophetic words of Rev. Bill Jones, we will stretch ourselves to think *beyond* honoring the legacy of Rev. Martin Luther King, Jr., this morning and this weekend, and consider what it really means to live into calls for civil rights in today's 21<sup>st</sup> century world.

Sunday, January 22, 10 a.m., "Walk the Maze with this Faith," Rev. Heather Rion Starr: Today's service is inspired by the 2019 Unitarian Universalist Pocket Guide, edited by UUA President Rev. Susan Frederick-Gray, who is now in the final six months of her five-year UUA Presidency. As we move towards a new UUA President, consider new proposed language for our UUA Bylaws (which include Unitarian Universalism's Purposes and Principles), what is "transient," and what is "permanent" about this ever-evolving UU faith? Following today's service, there will be a workshop open to all, led by Susan and Mac Goekler of UUSD's Denominational Affairs Committee, presenting the latest proposed bylaw changes at the denominational level. They will discuss how you can be involved in the ongoing development of the bylaws.

Sunday, January 29, 10 a.m., "Jean Charles Service Sunday," Paul Barnette and the Board of Trustees: Paul Barnette, Board President, will explain why he looks at service to the congregation as a spiritual practice. For the last 15 years, Paul has served the congregation in various capacities including three terms on the Board of Trustees. Many UUSD members have given the Jean Charles Service Sunday sermon over the past several years. They include Don Peterson, Kris Acker and the FUNdraising Committee, Deanna Duby, and Len Bowman, who spoke about our covenant articulated in our Principles and UUSD's Mission and Vision Statement. Those who have been with UUSD for some time are very familiar with this service and know its history. But if you are new to UUSD, you may be wondering what the Jean Charles Service Sunday is about. The Jean Charles Service Sunday was created several years ago by the Board of Trustees to honor Jean's exemplary service to the congregation. The Board felt Jean's unwavering dedication to service was a model for the congregation and deserved to be recognized in a special way. As a result, the Jean Charles Service Sunday was created to recognize each year the importance of leadership and service to UUSD.

### REV. HEATHER RION STARR, MINISTER



Dear UUSD Members and Friends,

I love being a parent of rambunctious, energetic kids; I love being a parish minister; and I love a lot of other things about my life these days. And...sometimes I do miss being able to read a book from front to back, from cover-to-cover. There just isn't time for that in my life right now. Except, maybe: winter break. There may just be a few days coming up here when I can read for more than five uninterrupted minutes. So, because there's the possibility of that, I have a whole stack of books ready to go (in my often somewhat unrealistic, over-ambitious fashion). Here they are in case you're interested and/or inspired to join me in savoring reading any of these!

First of all, I'm excited to dive into and really immerse myself in the wisdom of Elizabeth Andrew in her book, writing the sacred journey: the art and practice of spiritual memoir, which we'll be drawing upon for the two-part Adult Faith Exploration class I'll be offering in January (see further on in this newsletter for more details on that class). Even if you're not planning or able to take this class, the book is a treasure trove of encouragement and support for putting our most closely-held stories into words on the page—which I try to do for you for many a Sunday, so it's all grist for the mill.

Right in there with church-related books, I continue to carry around with me copies of *The Myth of the 200 Barrier: How to Lead Through Transitional Growth*, by Kevin E. Martin. I wrote about the value of this book for those of us in leadership at UUSD in my November Beacon column. As our Sunday attendance numbers continue to inch up, the wisdom and perspective this slim volume offers will continue to be useful for us all—and current Board members each have a copy as well.

We are also part of larger communities in Sussex County that have been engaging in conversations inspired by the book: *I Never Thought of It That Way: How to Have Fearlessly Curious Conversations in Dangerously Divided Times*, by Monica Guzman. I'm looking forward to learning from Guzman, who I understand also hosts a lively podcast.

As this congregation's Safer Congregation Team continues to refine its priorities and scope, I've found it helpful to pick up the book *Factfulness: Ten Reasons We're Wrong About the World—and Why Things Are Better Than You Think*, by Hans Rosling. There is so much in this book that is useful to be aware of when thinking about broad societal dynamics and how we human beings react, respond, and prepare for potential crises (and opportunities) of the future.

Other books that I carry around with me almost more as sacred texts than as ones I ever expect to sit and read cover-to-cover include: Who Do We Choose to Be? Facing Reality, Claiming Leadership, Restoring Sanity, by Margaret Wheatley, Trauma Stewardship: An Everyday Guide to Caring for Self While Caring for Others, by Laura van Dernoot Lipsky with Connie Burk, and When Things Fall Apart: Heart Advice for Difficult Times, by Pema Chodron. If I was on a desert island with other people, only three books and a lot of gluten-free granola bars, these are the books I'd want to have. I'd love to know what your books of choice would be!

I always enjoy hearing from you, via whatever mode of communication you prefer. You can reach me best by email, cell phone, text (ideally just for emergencies or scheduling logistics), first-class U.S. mail, or Facebook Messenger if you just have a quick question or comment. Let me know if there's something you'd like to say or check-in about (or want to make sure I am aware of). It is so good to co-create community with you, and to move alongside one another towards whatever comes. Happy New Year and may we all find ways to nourish our spirits and build meaningful community in 2023!

# PAUL BARNETTE, PRESIDENT, UUSD BOARD OF TRUSTEES (BOT) PRESIDENT'S MESSAGE AND BOARD HIGHLIGHTS

### November 22 Board Business Meeting

**Review of October Financial Report**: Co-Finance Officer Kent Sprunger led a review of UUSD's month-end financial documents including the October Summary Income & Expense Statement Reports for Operations & Capital Funds and October 2022 Balance Sheets. Kent clarified that the member loan (Schmidts) has been repaid with interest. Kent reminded the BOT that his goal is to begin tracking UUSD's financial data in QuickBooks in January or by February 2023 at the latest. This is also true for moving data management from PowerChurch to Breeze. The Board approved the financial reports unanimously as presented.

Executive Team Request for Additional Funding for Google Workspace Training Sessions in 2023: ET Representative Don Peterson provided a budget request detailing ET's need for additional funds to hire the GW Consultant to provide additional training on the Google Workspace Platform for those congregants that have not been able to take advantage of the training. After some discussion, Chris Leslie moved that the Board approve the funding request using funds from the FY23 budget. The motion was approved and seconded and the vote to pass the motion was unanimous.

**Review of the "Next Steps Weekend"**: Chris Leslie invited the BOT to review their experience regarding the conduct and content of the NSW process. The general consensus was that the process went very well, and the conservations with Mark Ewert were worthwhile and very informative for all involved. Next steps will be determined by the BOT in consultation with the Expansion Planning Committee once we have received and reviewed Mark's final report.

**BOT Strategic Vision for FY24:** Richard Wheeler proposed that the BOT reach out to the committees that have a Board Liaison to begin to identify FY24 goals and outcomes in preparation for naming a funding amount they will request early in the New Year for the FY24 budget. Everyone agreed that the BOT should take the lead in starting the FY24 budgeting process.

Bike Ride to Raise Funds for the Children's Playground Fund: Paul asked the BOT to consider approving his proposal that he and others from UUSD be allowed to conduct a three-day fundraising bike ride from the Northeast point in Delaware to Fenwick Island, Delaware to raise funds for the Children's Playground Fund. The ride would take place during the first week of October 2023. The motion was approved and passed unanimously.

### December 13 Board Planning/Business Meeting (Due to the holidays this was the only BOT Meeting in December.)



Review of November Financial Report: Kent Sprunger provided a review of the November 2022 Month End Financial Statements. Income was higher for the month due to both the Craft Fair and pledge income. Spending continues to be steady. The motion to approve the financial report was passed unanimously. December financials will be the final month for PowerChurch. The Chart of Accounts (COA) has been entered into QuickBooks. The COA is now a more mature and smaller structure due to collective work by Kent, Richard Wheeler, and Leah Thompson, our bookkeeper. Best practices from other UU Congregations have been utilized. Breeze is ready to go, with individual/family pledge data ready later in the Spring of 2023. After January 1, 2023, financial data will be tracked in QuickBooks. Vanco will be used until those using the Breeze system get comfortable with it.

**Presentation of Safer Congregation Team Charge:** Safer Congregation Team Chair Ruth Lamothe presented the draft charge for the Safer Congregation Team. The Board reviewed the draft charge and made recommendations for change to the document. Approval of the charge was tabled to allow time for Ruth to meet with the team and review the proposed changes. The revised charge is scheduled to be on the agenda in January 2023.

Ruth reviewed some of the procedures instituted in order to keep the congregation safe. The Team has been in touch with Seaside Jewish Center, Epworth UMC, Metropolitan Community Church (MCC), and Diaz Bonville of Westside New Beginnings, on their safety procedures. The Team has received one proposal from Alarm Engineering. Additional proposals will be requested after consultation with the Contract Review Team. Richard Wheeler suggested the Team develop a Statement of Work to provide potential bidders with a clear idea of what we plan to purchase.

**Update on FY24 Pledge Campaign:** Kent Sprunger updated the Board on the FY24 Pledge Campaign. The Sub-Committee has been meeting monthly with Ron Schaeffer as the Chair. The theme of the campaign will be "Dream It! Do It!" The pledge and budget subcommittees are working closely and have created a master schedule. There will be a "soft launch" for the campaign after the BOT approves the FY24 budget on February 14. In order to get a head-start on 100% leadership pledging, leaders will be asked to begin pledging after February 20. March 5, 2023 will be the campaign kick-off to the congregation.

"Brownie Incident" Next Steps: The second "Listening Session" facilitated by the UUA Trauma Response Ministry (UUTRM) was held on December 10 via Zoom. Resources provided by the team were emailed to members that were directly impacted by ingesting the brownies, spouses/partners, along with those providing support at the ER and at home. On Sunday, December 18, the BOT released a communication with a link to the updated Fact Statement to the members, friends, and staff of UUSD that stated we are moving towards closure of the incident. Anyone needing further assistance was asked to contact the Pastoral Care Team, chaired by Michele Cavanaugh.

**Short Term Visioning Process for FY 24 Budget:** Richard Wheeler gave the Board an update on the visioning process for the FY24 budget. The budget will be a challenging one this year with the following needs already identified: A/V Support for weekly services and special events, hiring of a half time Director of Children & Youth

Faith Exploration, and a proposed increase to the Landscaping Committee and Social & Environmental Justice Committee's budgets. Committees will be requested to submit budgets no later than January 23, 2023.

The BOT Planning Meeting takes place on the second Tuesday of the month at 10 a.m. and is a Hybrid meeting. The BOT Business Meeting takes place on the fourth Wednesday of the month at 3:30 p.m. via Zoom. Please contact Richard Wheeler or Paul Barnette for the Zoom link.

### LEADERSHIP IN ACTION...OUR UU FUTURE IS UP TO YOU!



The New Year is finally here, and our busy holidays are now behind us. With the start of a New Year, Leadership Development (LDC) is turning to the future and the opportunities for UUSD members to fill elected positions on the Board of Trustees (BOT) and LDC starting July 1, 2023. At this year's Annual Meeting in June 2023, the congregation will elect **three members for the Board of Trustees** and **two members for LDC**. Those elected will serve two-year terms from July 1, 2023 through June 30, 2025.

UUSD elects Board and LDC members by self-nomination. The self-nomination approach is transparent and democratic. Enriched by our diversity, we seek nominations from everyone, regardless of race, physical ability, socio-economic status, gender identity, whom you love, or any other human characteristic. Any UUSD member interested in serving in an elected leadership position on the Board of Trustees or on LDC can self-nominate themselves for these positions.

LDC is responsible for managing the self-nomination process and the election. This work is organized under LDC's *Guided Pathways: From Member to Mentor*.

Here is what you can expect in the months ahead:

- 1. **January March**: LDC will send a special email to the congregation in late January with additional information about the self-nomination process, including the Self-Nomination forms and descriptions of the positions on the Board and LDC.
- 2. **February March**: LDC will hold interactive prospective candidate sessions about serving on the Board of Trustees and LDC. The self-nomination process will close at the end of March. Everyone is welcome to join these sessions and learn more about the process.
- 3. **April May**: LDC will share information provided by the self-nominees to the congregation. LDC will also sponsor Candidate Forums for BOT and LDC self-nominees so the congregation can get to know them and their qualifications to take these important positions at UUSD.
- **4. June** The congregation will vote at the Special Meeting in June for those that want to serve on the Board and in LDC positions for the 2023-2025 terms.

This is an exciting time to consider becoming an elected leader at UUSD and sharing your experience, talents, and dedication with your loving UUSD community.

# DENOMINATIONAL AFFAIRS WORKSHOP, SUNDAY, JANUARY 23, 11 A.M. THE REWRITE OF UUA BYLAW ARTICLE II—WHERE OUR UUA PRINCIPLES RESIDE



The UUA has a Bylaw Article II Commission that has circulated concepts for a new Article II. UUSD will have a workshop following the Sunday Service on January 22 to address these changes.

This UUA Bylaw section describes us as UUs and our UU Association. The Inclusion, Freedom of Belief, and Purposes are still there—in modified form. They have updated the principles—now called Values and Covenant, forward looking statements. An addition to this section is a graphic

of these Values Centered in Love. The Sources are now Inspirations.

After a series of outreach sessions (Mac and Susan Goekler were facilitators) and modifications, the Commission is now ready to present to the UUA Board a draft in mid-January. Mac and Susan plan on presenting this latest revision during the workshop.

The UUA Board will review and maybe amend this draft and put it in the June 2023 final agenda for General Assembly (GA).

Beginning in March, there will be public forums on this draft, and likely in May or June, there will be GA Mini-Assemblies. This is where GA Delegates can suggest amendments. At GA after a debate, there will be a vote—a majority sends this final version to GA 2024 (likely a virtual GA) for a final 2/3 vote to make this part of our UUA bylaws. UUSD needs a full slate of GA delegates as this is important. There will be another workshop on this issue in March 2023.

### FINANCE RON SCHAEFFER, CHAIR

The financial picture for the month of November, the fifth month in our fiscal year (FY July 1, 2022, through June 30, 2023) continues to be positive. Our pledge commitment for the entire fiscal year is \$304,353, and we collected \$41,267 or 13.6% in actual pledge fulfillment in the month of November. Our pledge fulfillment through the first five months of the fiscal year is 56% of our total pledge commitment. Our income and expenses paid through November 30 are as follows:

- Total income: \$197,895 (58% of the total budget)
- Total expenses: \$127,830 (38% of the total budget)
- The net operations surplus through the end of October: \$70,065.

This is a good start for the first five months of the fiscal year. Committee expense is always below budget in the early months and is currently at 20% of budget, while staff compensation, mortgage payment, and facilities costs are more up to date.

Our thanks to all our members and friends who support UUSD. We hope this information is helpful to you, and we welcome your questions and comments.


### PROPERTY MANAGEMENT WHAT IS "NET ZERO," ANYWAY?

It's been over six years since our solar panel system was completed in October 2016. Property Management's Energy Team has been monitoring the system performance and the building's energy usage on a monthly basis.

Here's a report from the Team on the current operation of the system.

When the 105 panel array was installed, it not only covered the entire west roof of the sanctuary, but was also the largest that Delmarva Power (DPL) would permit, as it was sized to generate 85% of the power that we were then consuming (about 36,000 kilowatt hours (kWh) per year). As we continued conservation efforts and fine-tuned the thermostat programming, we were generating 100% of our usage before the COVID shutdown, as the following graph illustrates:

### **UUSD Solar Production and Usage**



The green bars show our energy production, which exceeded our usage for seven months in 2019. By the end of October, we had generated over 9000 kWh of excess electricity, which flowed back into the DPL power grid. DPL keeps an "Excess Generation" account, which was then debited through the colder months of the year. By the end of March, the account was nearly depleted, and DPL credited us a small amount on that bill.

So that is "net zero" usage: On an annual basis, generating as much energy as you use.

During the COVID shutdown, we were generating over 120% of our usage, but it's not meaningful to use from that period. We are now back to "net zero" for calendar year 2022, generating and using about 30,000 kWh annually.

Our DPL bills are consistently \$18 a month, which is our fixed "customer charge." We don't own the solar panels and inverter equipment—they are leased from Clean Energy USA for a lease payment of about \$200 each month. This has been a good deal for us from several perspectives: (1) we didn't have capital cost to install the system, (2) monthly cost is known as opposed to variable monthly DPL bills, and (3) we don't have to maintain the equipment.



### FILM AND POTLUCK, FRIDAY, JANUARY 13, 5 P.M. UUSD CARES & SOCIAL & ENVIRONMENTAL JUSTICE



All are invited to a bread and soup potluck starting at 5 p.m. on Friday, January 13, at UUSD. This will be followed by a showing of the film *Who We Are: A Chronicle of Racism in America* with discussion to follow. There will be an alternate activity for children during the film. Please bring soup, a salad, or bread to share if you come to the dinner. Check the weekly *UUSD eNews* for more information.

Who We Are: A Chronicle of Racism in America is a documentary feature film that confronts the painful history of slavery and anti-Black racism in America head on. Former ACLU Deputy Legal Director Jeffery Robinson was 11 years old when the Reverend Dr. Martin Luther King Jr. was murdered in Robinson's hometown of Memphis, Tennessee. Before King's murder, Robinson believed the country had

reached a "tipping point," and true racial equality was within reach. When King was killed, it felt to Robinson like the movement died with him. How, he wondered, did we get here?

In *Who We Are: A Chronicle of Racism in America*, Robinson asks all of us to examine who we are, where we come from, and who we want to be. The film interweaves historical and present-day archival footage, Robinson's personal story, and vérité and interview footage capturing Robinson's meetings with Black change-makers and eyewitnesses to history. Robinson shows how legalized discrimination and state-sanctioned brutality, murder, dispossession, and disenfranchisement continued long after slavery ended, profoundly impeding Black Americans' ability to create and accumulate wealth as well as to gain access to jobs, housing, education, and health care. Weaving heartbreak, humor, passion, and rage, Robinson's words lay bare an all-but-forgotten past, as well as our shared responsibility to create a better country in our lifetimes.
