Cloud Society Guidelines

The goal of the Cloud Society is to create awareness amongst UUSD members as to how you can provide for the long-term viability of the congregation without any cost, simply by designating UUSD as a beneficiary in your will or life insurance policy, both, or even by establishing a pre-death gift.

As a donor, you may establish restrictions for the use of your gift if restrictions do not violate the law, the Principles and Purposes of the UUA, or the bylaws and policies of UUSD. It is the responsibility of the Finance Officer to assure that any gift restrictions approved by the UUSD Board of Trustees are honored in perpetuity. Gifts without restrictions will be deposited into the UUSD capital fund for investment in the long-term viability of the congregation as capital needs dictate. Unless so restricted, donors' gifts would not be used to fund UUSD operations.

A Legacy Opportunity

Becoming a member of The Cloud Society is available to members and friends as a gesture of perpetual love and care for the Unitarian Universalists of Southern Delaware.

Becoming a Cloud Society member is as simple as making a designation through your will, trust, or beneficiary arrangement. You may designate whatever amount feels comfortable – no minimums or maximums – and it is not an irrevocable gift. Donors may establish restrictions for the use of their gift, as long as they do not violate the law, the principles and purposes of the UUA, or the bylaws and policies of UUSD. Living gifts are accepted. If you are interested in growing your legacy with UUSD, return the enclosed enrollment form.

A vision for a bright future...

In 2009, Dan Payne chaired a Legacy Committee which led to the establishment of the Cloud Society so that UUSD members and friends could make a legacy gift to the continued life of their beloved congregation. In December of that year, the UUSD Board of Trustees approved the formation of a legacy organization to be called the Cloud Society as a sub-committee of the Finance Committee with the authorization to manage this legacy program.



Twelve inaugural members were inducted in March, 2010. In the decade since the Cloud Society was created, over thirty additional members have planned gifts to our faith community's future. Each one has made gifting plans to help ensure that UUSD continues its work for the next generations. Their names are inscribed on gold tone metal leaves mounted on Gabriel Zapecki's beautiful Tree of Life wall carving in UUSD's gathering area.
