

UUSD June 11th 2023 Annual Meeting

Opening words and Chalice Lighting were given by Rev Heather Rion Starr.

The meeting was called to order at 11:30 am by Paul Barnette, President UUSD Board of Trustees who chaired the meeting,

Following a brief welcome from Paul the meeting began.

Quorum Count Jane Miller Board Secretary declared that a quorum was present, noting more than 71 members had checked in and received ballots.

Julie Keefer reported on the choir's work over the past three years. She expressed her deep appreciation for everyone's efforts to assure there was music for services despite many pandemic-related challenges. Also, she thanked Dianne Conine for her many years working with AV.

Report on the Balloting

Linda Marsden reported:

- All 3 motions carried.

Paul offered closing remarks noting UUSD had done the business of an annual meeting, elected BOT and LDC leaders; approved a budget for the upcoming fiscal year; reached critical decisions on items presented for congressional vote. Paul encouraged everyone to continue to move UUSD forward honoring the decisions reached, supporting our leaders, and work within the FY 24 budget ahead for UUSD.
