We have 4 confirmed members for the Stewardship Ministry Team (target is 4-5); Jane will reach out to the group and get the committee going.
 - c. Searching for the Future Strategic Plan All: The Board is working towards its goals (creating the two committees above and setting up 3rd Sunday of the month meetup with Board members after service). Carol will mention to committee chairs at this Friday's Church Council meeting that they should be working toward their goals as well.
 - d. Preliminary Info on Craft Fair: \$10,585 raised, a great outcome. Biggest day was Thursday. A huge thank you to the Fundraising committee.
 - e. Discussion of how to support All-Congregation Events and Gatherings, and who can oversee them. These events are a lot of work and we're always looking for more help. ET will explore working with UUSD Cares re set up and take down of all congregational events.
