August 7 — Even the Rocks Cry Out "Enough" — Rev. Paula Maiorano, Interim Minister: This is a service of lament expressing feelings of grief, sorrow, anger, and outrage at the unnecessary loss of lives driven by the hate and senseless violence that is much, much too pervasive today. Traditionally, liturgical lament is the way a community of religious people, such as ours, deepen their bonds with one another and strengthen their ways of hanging on to that which is life giving and trust worthy.

August 14 — The Language of Reverence, the Rhetoric of Peace — Rev. Paula Maiorano, Interim Minister: What we say and how we say it matters in all of our relationships, interactions, and endeavors, especially in our spiritual community. Nonviolence is a lifestyle that is lived with mindfulness and intentionality. It asks for compassionate transformation at the deepest level. A language of reverence is a transforming catalyst. Let's use more of it.

August 21 — Reflections on the Man, his Faith, Work, and Book — Rev. Paula Maiorano, Interim Minister: Rev. Maiorano reflects on the prophetic leadership of the Rev. Dr. William J. Barber II, introduced at the UUA General Assembly by President Peter Morales. A blueprint for a breakthrough in justice is offered in Rev Barber's new book, *The Third Reconstruction: Moral*

Mondays, Fusion Politics, and the Rise of a New Justice Movement. This movement is worthy of our investigation.

August 28 — Unscripted II — Rev. Paula Maiorano, Interim Minister: A reprise of last year's unscripted service focuses on the interim period between settled UUSD ministers. Bring an index card with your questions, wants, hopes, and fears for this all-important second and final year of interim ministry. Rev. Maiorano will craft her sermon extemporaneously in the direction your queries and comments lead her.

You may have seen the UUSD Facebook posts of our group of delegates and attendees at the General Assembly in Columbus, Ohio. If it looked like we were having a great time, we were! We had quite the group, all participating in various workshops, protests, and activities

which expanded our awareness of UUA initiatives and deepened our commitment to them. My service to you this coming year will be enriched by my experiences in Columbus. Notice that the service on August 21 is a direct response to becoming better acquainted with the prophetic ministry of the Rev. Dr. William J. Barber II.

I always participate in the General Assembly activities sponsored by our Unitarian Universalist Service Committee, and this year was no exception.

In the midst of so much heartbreaking loss of life in our country and around the world recently, it is important to stay reminded of the good and positive things that are still happening, but are not capturing any headlines. For that reason, I am sharing the following post, which is found on the segment called "Rights Reading" on the website of our Service Committee at www.uusc.org.

"An L.G.B.T. Watchdog at the United Nations" Opinion, *New York Times*, July 1, 2016 — The N.Y. Times' Editorial Board's brief endorsement of the creation of a global watchdog for discrimination and violence against L.G.B.T. people seems like a shorter-than-deserved mention of a significant event in the advancement of human rights at the United Nations.

As Charles Radcliffe, chief of global issues at the United Nations Office of the High Commissioner for Human Rights said, "This is a big deal. Ten years ago, you hardly heard the words 'gay' or 'trans' at the U.N." The fact that the initiative was introduced by Latin American countries with support from Europe is also telling, given resistance to programs protecting L.G.B.T. rights from Latin America not long ago. Opposition from African and Muslim countries was disappointing, but overall, the existence of this board is a promising development, and its activities bear watching.

UUSC is hopeful that U.N. support for L.G.B.T. rights will enable its African partner organizations to increase their efforts to advance their pioneering work to advance these rights and bring a new more just and welcoming world for all people in that continent.

On this hopeful note, I close.

During the growth planning process and particularly as we implement our plans, maintaining effective communication will be critical. In future President's Columns, I will explore with the congregation ways to enhance communication between the congregation and the Board. To start, I will be posting the Board's agenda at least three weeks before a Board meeting. Having the agenda out earlier should give everyone more time to understand the issues before the Board and, if desired, you should have the time to express concerns or suggestions.

HIGHLIGHTS: JULY 12, 2016 UUSD BOARD OF TRUSTEES MEETING

— Gwen Johnson, Secretary, Board of Trustees

Election of Officers: The new Board elected the following officers: President: Gary Colangelo; Vice-President: Sharon Herb; Finance Officer: Pat Murdock; and Secretary: Gwen Johnson.

Consent Agenda: The Consent Agenda, consisting of the June 7, 2016 Board meeting minutes and the Financial report, were approved. An Interim Minister's report was not filed this month.

Financial Report: Gary Colangelo, Finance Officer: Gary Colangelo reported we are in good financial shape and have a surplus of approximately \$12,000 this year.

Report on Meeting with Ministerial Settlement Representatives (MSR): Jean Charles, Chair

- Jean Charles reported the Ministerial Search Committee (MSC) met with Reverend Craig Hirshberg, our Ministerial Search Representative from the UUA, on Sunday evening July 10 and on Monday July 11, from 9 a.m. 4 p.m.
- Jean said the MSC has a very busy schedule and she encourages all congregation members to attend upcoming cottage meetings with the MSC, and to complete surveys they will be sending out to the congregation. These meetings and surveys will be used to assist the MSC in search of our permanent minister, and ensure the entire congregation has a chance to voice the qualities they would like to see in our settled minister.
- Jean requested the BOT provide two or three names of members of the congregation to serve on the Negotiating Team for the MSC committee. Pat Murdock was asked to be the BOT representative for the MSC committee, and she agreed to do it.

Report from Property Management: Gary Schmidt, Co-Chair

- Gary Schmidt reported on items contained in the document "Property Management Committee Report July 12, 2016" located in the UUSD members section of the website under July 2016 Monthly Board of Trustees Meeting Documents (http://www.uussd.org/images/2016-July-BOT-Meeting/Project-Management-Comm-report.pdf)
- Gary advised that Phase 1 of the Solar Panels have been installed.
- Gary also reported that UUSD received free professional consultation from the Delaware Forestry Department for our property.
- Diane Conine and Margaret Keefe are working with a University of Delaware intern on landscaping plans for the property. This service provides credit hours for the intern.

Denominational Affairs Request to Recognize Chalice Lighters: Ron Schaeffer, Co-Chair

- Ron Schaeffer requested the BOT approve the posting of names of congregational members who are Chalice Lighters. He suggested the names be posted next to the Chalice Lighters information in the Gathering area.
- The BOT approved this request.

2017 UU Delmarva Cluster Retreat: Pat Schaeffer, UUSD Cluster Representative

- Pat Schaeffer reported the Delmarva Cluster Committee is concerned that the current location in Maryland for Delmarva Cluster Retreats may be a barrier for broad participation from Cluster congregations especially because of its distance for most congregations.
- Depending upon the outcome of the 2016 Cluster Retreat, the Cluster Retreat Committee may request UUSD to host the 2017 Cluster Retreat in Southern Delaware.
- After a lengthy discussion, the BOT felt it could not take on this major responsibility in 2017 because of the congregational focus in identifying a new settled minister during this timeframe.

Request to Approve to Special Plate Collection by First Unitarian Church of Wilmington: Joanne Saltzberg, Finance Co-Chair

• Joanne Saltzberg advised that \$1,500 was cut from the FY 2017 Budget for the Religious Education Director's training. JoAnne asked for Board approval to have First Church of Wilmington take a special plate collection to assist with this need. The BOT approved this request.

FINANCIAL REVIEW FOR FISCAL YEAR 2015 (7/1/14 - 6/30/15) YIELDS GOOD RESULTS

A second pair of eyes is always a good thing when it comes to financial management, and UUSD's By-Laws require an annual, independent review of the church's financial records and accounting practices. In May of 2016, a review of Fiscal Year 2015 was conducted by the Board-appointed Financial Review Committee that included Patricia Murdock, Joanne Saltzberg, and Lee Summerville ably assisted by Jane Miller. The review team looked at four major pieces for this work:

- Overview of the organization's year
- Testing different accounting areas
- Analysis of accounting practices with recommendations for improvement, if any
- Opinion as to whether or not Financial Statements for the year fairly represent the financial position and are free of material misstatements.

A lot happened in the time period of July 1, 2014 — June 30, 2015. These dramatic and challenging events forever changed the financial and organizational life of UUSD.

- The congregation acquired a large property on which to build the congregation's first permanent home.
- Construction was planned to begin in August of 2014 and be finished in February of 2015. A number of setbacks
 delayed construction and prevented completion until September 2015. Approved budgets were skewed because of
 the delays.
- The long-term minister left in June of 2015, and an Interim Minister was appointed in that same month.
- The accounting system changed from QuickBooks to PowerChurch.

Three key areas were reviewed by the team:

- Bank statements for all four bank accounts were compared to financial records for two time periods. The result is
 that all checking and savings account statements for six months and year-end matched the reconciliation detail
 sheets. No discrepancies were found.
- Deposits were traced for five randomly selected Sundays. All five Sunday collections were documented with a UUSD collection form and verified with double signatures. All categories of donations were traced from the UUSD collection form to the proper account deposit and accounting entries. There were no discrepancies.
- Expenses payments to both committees and vendors were examined. Eight reimbursements to four randomly selected committees were reviewed. All requests were properly submitted, documented, and within budget. Land and Building authorized large sums of money in this year. Payments to three, randomly selected vendors were

reviewed. All payment requests were properly documented and recorded. The result is that all payments were tracked to either QuickBooks or PowerChurch, and there were no discrepancies.

UUSD experienced a significant change in assets in the year reviewed. As of June 30, 2014, assets were stated as \$1,289,554, the increase due to the acquisition of the property in Lewes, Delaware and construction of the new buildings. The bank accounts for the June 30, 2015 Balance Statement were verified.

After this intensive review, the team was happy to report that no discrepancies or missteps were discovered in what was a very challenging year. Financial reporting was very good overall except for some budget challenges associated with construction delays that are now resolved. It was the unanimous conclusion of the FY15 Financial Review Team that the Financial Statements published as of June 30, 2015 fairly represent the financial position of UUSD and are free of misstatements. DID YOU KNOW? — RON SCHAEFFER

THE YEAR OF THE WOMAN SERIES Part II: Julia Ward Howe

Last month, I began a series of monthly articles on famous Unitarian and Universalist women who played key roles in the suffrage movement in the U.S. As I indicated, many women from various backgrounds and faiths played important roles in bringing about the right to vote for women in 1920. However, the leadership, and particularly the early leadership, came from women who also found their religious faith in Unitarian or Universalist congregations. Last month I provided a brief sketch of Lucy Stone, and this month I will highlight the life of Julia Ward Howe.



Julia Ward Howe, born in 1819, was one of seven children raised in the home of a wealthy banker in Rhode Island. She was educated by a personal governess and in young ladies schools. Her mother died when she was five, and an aunt raised her. Her father died when she was twenty, leaving her a small legacy. She published articles in the *New York Review* and the *Theological Review* before marrying Samuel Gridley Howe. He forbade her public writing. Quite a different start than that of Lucy Stone.

They moved to Boston where she studied languages, wrote poetry, and became a Unitarian. Her marriage was difficult, but she settled on living separately instead of divorcing. In 1862 she wrote and published the "Battle Hymn of the Republic." This made her a popular public figure overnight.

After the Civil War, she became one of the leading organizers of the women's movement in New England, along with Lucy Stone and Caroline Severance. When the national women's suffrage movement split in 1869 over the issue of the Fifteenth amendment, which gave voting rights to Black men, but not to women, she and Lucy Stone supported it arguing that Black men needed the vote to survive. They formed the American Woman Suffrage Association. Susan B. Anthony and Elizabeth Cady Stanton took the opposite position and held out for universal suffrage. They formed the National Woman Suffrage Association. In 1890, Julia Ward Howe was instrumental in uniting the two national suffrage organizations that had split 21 years earlier.

She fought for women's rights for the rest of her life, and was the founder of the Association for the Advancement of Women. She toured the country as a lecturer and founded women's clubs wherever she went. In 1908 she was the first woman to be elected to the American Academy of Arts and Letters. She died in 1910 and more than 4,000 people

attended her funeral at Mount Auburn Cemetery in Cambridge, Massachusetts, and they sang the "Battle Hymn of the Republic" in her honor.

Next month we will look at the life of Susan Brownell Anthony, who was born into a Quaker family, but became a Unitarian because of its support for abolition of slavery. If you are interested in more detail on these heroines, a great source is *Unitarian and Universalist Women — Liberating History*, published by the Unitarian Universalist Women's Heritage Society, copyright 2008. It chronicles the lives of 119 Unitarian, Universalist, and UU women covering the period 1743 to 2003.

On Sunday, July 10, Rev. Craig Hirshberg delivered a sermon on *It's Only Change*. She spoke to the congregation about the ministerial search process and how everyone can be involved. Rev. Craig is UUSD's Ministerial Search Committee's MSR (Ministerial Settlement Representative). She serves us through the UUA's Transition Office.

Hopefully, many of you had a chance to meet Rev. Craig during coffee hour before she met with the outgoing and incoming Board members. Sunday evening was a working dinner committee meeting at Betty Kirk's home from 6:00 p.m. until 10:00 p.m. On Monday, July 11, Rev. Craig presented a workshop from 9:00 a.m. — 4:00 p.m. on the search process, helping the committee assign to specific duties for each member and to work on a calendar of deadlines. The entire committee agreed that the extra time and energy put into these workshops was invaluable, and Rev. Craig is a great consultant for us to depend on to walk us through the search process.

The survey from the search committee should be well on its way to being shared and completed. The results will be posted on the UUSD website under the Settled Ministerial Committee News. We can't stress enough how important it is to respond to anything the Search Committee offers to you. All of the information gathered from the survey and meetings will help the committee make the best decision for UUSD. Although anyone is welcome to participate in all activities, keep in mind that in the end, **only members** will vote for the final candidate.

In the upcoming months, the Search Committee members will be interviewing staff (LSFD Director and Music Director) along with church leaders, such as committee chairs and the Board of Trustees. During the month of September, you will be asked to attend a Cottage Meeting (focus group). These face-to-face meetings with a Search

Committee member and about 15-20 people will allow us to ask some important questions. An example of that might be — "How would you describe this congregation to a prospective minister?"

Please keep in mind that your Search Committee is always available for comments or questions at any time. We are here to receive and record as much information from our congregation as possible to help us in this very important decision.

With the theme of "Heart Land: Where Faiths Connect" this year's General Assembly (GA) held June 22-26 in Columbus, Ohio was inspirational and exciting for the 3,780 onsite participants and 154 offsite participants who attended. Thirteen UUSD members and friends participated in GA 2016: Rev. Paula Maiorano and Giovanni Maiorano; Jean Charles and Anne Pikolas; Ron and Pat Schaeffer; Amber Peterson; Dianne Conine and Margaret Keefe; Dan and Ceil Payne; and Susan and Mac Goekler. A total of 1,842 onsite and offsite delegates represented 562 congregations. Pat and Ron Schaeffer, as well as Rev. Paula Maiorano, served as delegates representing UUSD.

The first phase of our solar energy system was installed on our sanctuary roof by Clean Energy USA on July 12. The system was inspected on July 18 and Delmarva Power has installed their meter. On July 25, Clean Energy USA activated the system, and the solar panels began generating clean renewable solar energy. This phase will provide a substantial portion of our power needs — the final phase will be designed and installed based on experience with the initial system. We will be able to monitor our daily energy production, and we will provide frequent reports in the UUSD newsletter, website, Facebook, and the *Community Update*.

LANDSCAPE MANAGEMENT SUBCOMMITTEE THINGS ARE BLOSSOMING AROUND UUSD

You have probably noticed and hopefully enjoyed the beautiful flowers around our church home. Volunteers bought and planted them, and other helpers have stepped up to donate hoses and keep them watered and prospering. We extend a huge thank-you to all who have helped. The list of watering volunteers is on our bulletin board, so please thank them when you have a chance.

The flowers are a quick way to beautify our home while we explore long-term plans and ideas. Through a connection made by one of our members, we have arranged for an internship with a Landscape Design student at University of Delaware (UDel). This young woman from Lewes will work under the supervision of a UDel professor to help identify our current plantings and design future areas that will feature sustainable gardening practices, include native plants that are hospitable to wildlife and enhance the beauty of our wonderful, peaceful setting. The intern will draw up plans that can be implemented in stages, as our volunteer energy, time, and finances allow. Once the plans are in place, we may solicit the congregation's help in obtaining the plants we need. One way to do that will be to ask for cuttings of specific plants from your own gardens. A second option will be for members to donate money to buy a plant in memory of or to honor a loved one. We will place tags on the plants to commemorate that donation. It will be similar to our Bricks for Chairs project where you can step onto our patio and view the memorial bricks.

Some people have asked about the status of the Meditation Garden. Rest assured that there is still every intention to create such an area, possibly in the back east corner of our property, with views of the pond and areas for sitting in quiet contemplation. Most of those who were initially engaged in planning the Meditation Garden have morphed into members of the current Landscape Management Subcommittee, created to get a handle on the immediate area around the building. There is also the possibility that our UDel intern will be able to continue working with us to help design the Meditation Garden and a labyrinth. As originally planned, the memorial bricks from the Bricks for Chairs project will be transferred into appropriate places in the Meditation Garden. One other aspect of the Garden that people have inquired about is whether it would be a place where people could spread the cremains (ashes) of a loved one. Some churches offer this service on their grounds. It is something that would need to be explored further, both as a congregation to determine if there is a will/desire to do this and also to determine the various legal and code restrictions that might apply. All of these ideas are very much in the *what if* stage and open to discussion and exploration.

Recently we met with a representative from the Delaware Forest Service to discuss the trees on our property. He gave us the good news that our trees are quite healthy. In addition, he shared information about managing them wisely, along with suggestions for additional plantings to create a western boundary hedgerow and a possible buffer between the parking lot and sanctuary.

The current Landscape Management Subcommittee consists of Dan Acker, Len Bowman, Dianne Conine (Co-Chair), Sally Crouch, Jim Gervan, Jena Hom, Margaret Keefe (Co-Chair), Anne Pikolas, and Paul Skillin. We are a subcommittee of the Property Management Committee. We welcome anyone who enjoys working with plants to join us as we move forward with the external enhancement of our new UUSD home.

This performance is part of their "One Day Baby" 30 city tour across the U.S. to promote their upcoming debut album, *One Day Baby*, scheduled for release in October. The album features Allison Miller (Brandi Carlile, Indigo Girls), Tood Sickafoose (Ani DiFranco, Anais Mitchell), Matthias Kunzil (Regina Spektor, Moby), Jenny Scheinman (Lucinda Williams, Bill Frisell) and Kyle Sanna (Edgar Meyer, Chris Thile). Famous October (Sarah Bowman and Rene Coal) are two singersongwriters currently living in Switzerland with their one-year-old daughter Cecilia Anne. Sarah and her twin sister Claire are daughters of Len Bowman, UUSD member and proud father.

Though both artists are from different hemispheres, it was their individual fervent pursuit of their music that inevitably brought them together. Burrell grew up in a peaceful small Swiss town at the foot of the Alps while Bowman grew up in a high crime and economically depressed neighborhood in racially tense Davenport, Iowa. By age 19, Burrell had achieved national recognition in his native Switzerland as a BMG alt-country artist, having been nominated for a Swiss PRIX

WALO award and opening for Neil Young, ZZ Top, and Amy Winehouse. Enamored with Americana music, Burrell stumbled upon a show in Luzern featuring the twin sister duo, The Bowmans, who had been touring internationally for four years.

On the other side of the world, Bowman had been raised on her Bronx born mother's collection of 60s protest songs and her Detroit native father's classical music. She studied cello, piano, and vocal performance, as well as music education graduating with Honors from Duquesne University and Notre Dame of Maryland University. She sang as a

soprano with the Baltimore Symphony Choir and worked with Yuri Temirkonov and Bobby McFerrin. Bowman and her twin sister, Claire, began singing together at coffee shops since they were 14, and eventually grew up together touring through the U.S. and Europe. Individually, Bowman and Burrell had released four or five acclaimed albums and had developed thousands of fans internationally before joining together as a duo. Their individual success set the stage for the duo's success to come.

Since officially coming together as *Famous October* in 2012, Bowman and Burrell have amassed an international following with their initial tours through Switzerland, Germany, the Netherlands, and the U.S. In their first collaborative year, they won a number of prestigious Swiss music awards and were commissioned to compose an embodiment of the 300th anniversary of the great "Stans Brandnacht 1713," an excerpt of which appears on their upcoming debut album. In addition, the duo run their business, Pillow Song, which started off as a listening room for touring musicians in their rehearsal space in Stans and has grown into an international music community in which artists support one another. Pillow Song also acts as the label and management for *Famous October*.


